**GENERAL STATEMENT OF POSITION:**

The Post Majority Caseworker is responsible for working with Youth/Adults to assist as needed with Addictions support to ensure a successful transition to independence. This includes collaboration with the Permanency Unit, TAP/SFP Unit and Prevention Unit. This role supports educational and/or career planning for youth and to Act as an advocate for the Youth to support their transition to independence. The Post Majority Caseworker will develop and implement effective strategies to support youth/adults to reach self-sufficiency within their community, to enhance the safety, security and independence of youth/adult formerly in care. The Post Majority Caseworker will ensure the collaborative efforts between community members, programs, leadership, other stakeholders and staff improve the safety and living conditions of families. The Post Majority Caseworker is responsible for the implementation and delivery of the Siksika Children's Services Program in accordance with Siksika culture and traditions incorporated by the agency.

**Duties & Responsibilities:**

- Works collaboratively with Siksika Children's Services Child Protection Teams and Prevention Team to assist youth with their transition to independence and ensuring all necessary assessments are completed. Supports youth and young adults with addictions and accessing services.
- Conducts and guides the youth/adult through their education plan, career plan, cultural goals, accommodations. Education and Career planning that includes training, job seeking, resumes, etc. to ultimately reach their education and/or career goals.
- Mentor youth/adult to become independent through accessing and advocating for resources including housing, educational funding, career training, personal identification. Assist youth/adult with navigating programs such as Advancing Futures, Registered Education Saving Program, PDD and AISH, The office of the Public Guardian and Trustee, Office of the Child and Youth Advocate and the TAP Program.
- Ensures that all youth/adult have a complete genealogy to establish identity and promote cultural awareness in collaboration with the Prevention unit to provide cultural programming for youth.
- Encourages healthy living (personal health, personal care, home skills, family support) and responsible decision making.
- Monitor youth/adult and follow up with relevant addiction supports/resources on a daily basis. Addictions Support Worker will keep monthly synopsis of youth/adults.
- Liaises with related health professionals such as Alberta Health Services, Addictions Supports, City of Calgary Police/RCMP, Doctors, Hospitals, Justice/Court, Education and all Siksika community services that youth/adults are utilizing services with.
